

FAMILY COMMITMENT POLICY

For the School to flourish as a spiritual and educational environment, CHC must have the full support and cooperation of both our students and their parents regarding administrative decisions and operations. Together with your enrolling child(ren), please prayerfully and thoughtfully review the following statements.

- a. For the benefit and welfare of the entire student body, I agree to adhere to the School's policies, rules and regulations, as described in the Parent/Student Handbook, including disciplinary action. The School reserves the right to disenroll a student at any time and for any reason, and that neither the Handbook nor this document limit that right. [The current Handbook can be accessed online or the School office can provide a copy.]
- b. I invest authority in the School to discipline my child as necessary in accordance with the Parent/Student Handbook. I agree to cooperate with and support the School's disciplinary action regarding my child's attitude and behavior by further addressing such issues at home.
- c. If my child has difficulties with other students or with the School's rules of behavior, I will not register any disputes with the other families involved, realizing such discussions could breed contention rather than resolution. Rather, I will discuss the matter with the principal, director, or involved CHC staff.
- d. I agree that CHC has full discretion over grade placement and/or teacher assignments for my child.
- e. I understand that assessments will be made to cover any damages to CHC/CHCC property if my child is found responsible for such. I agree to reimburse CHCC in a timely fashion for assessed damages.
- f. I commit to pray for CHC students, faculty and administration.
- g. Recognizing that private education requires strong parental support, I agree to frequently participate at CHC events or attend my child's classroom programs or school activities.
- h. I understand our continuing enrollment at CHC is dependent upon the student's spiritual growth and academic progress, as well as the parents' and/or student's appropriate behavior and attitude.
- i. I agree to the entire CHC Enrollment Agreement between the parties hereto and I acknowledge that it supersedes any previous agreements or understandings whether oral or written. By signing or initialing all parts of the Agreement, we the parent(s) or legal guardians and the School acknowledge that parties have read and understand all the terms and conditions of this Agreement and agree to be bound by this Agreement.
- j. I further attest that I have full authority as parent or legal guardian of the above child to enter into this Agreement. I understand that it is my responsibility to inform the School of any address or contact information change for our family or those listed as contacts on any forms submitted to the School.

[NOTE: BOTH married parents, or divorced parents with joint custody, or all legal guardians with joint custody must sign this Family Commitment Policy along with each enrolling child in Kindergarten through Grade 8.]
